

PRIVACY policy for pegasusstudios.com.au

Website privacy notice version 2.1 – issued 06 June 2023.

Preamble ...

This document explains this website's data gathering and data storage practices:-

1. other than data entered by a visitor into this website's contact form this website itself does not gather data from its visitors and therefore does not store such data – put simply this website does not gather or store data from its website visitors;
2. data entered in the contact form, after the send button is pressed, is automatically sent via the website's email server to the nominated recipient (who is the website owner);
3. when the contact form email is received it may be stored in the recipient's email client (app) on the recipient's device(s) – this email will be deleted in due course by the recipient in the normal way;
4. this website does not have user data to sell or pass to third parties.

About the website's shop ...

1. the website owner uses a trusted independent third-party platform for the sale of its products and services linking its website to the third-party platform;
2. this third-party is clearly identifiable upon entry into this website's shop;
3. this third party is responsible for advising visitors to its platform of its terms and conditions and explaining its privacy policy;
4. financial transactions on this site/platform are via PayPal, a trusted merchant, with funds transferring from the customer direct via PayPal into this website's owner's PayPal account – information relating to the transaction is passed by PayPal to the recipient for fulfilment of the goods and services purchased;
5. PayPal is responsible for advising those using its platform of its terms and conditions and explaining its privacy policy;
6. at the time of writing this document PayPal was selected for its perceived market leader position in its security practices and ease of use;
7. data relating to the transaction is stored by the website owner offline and securely kept for order fulfilment, accounting, and tax purposes only;
8. data is not passed or sold to third parties other than as prescribed by law for accounting and tax purposes.

About other third-party services used on this website ...

1. to enhance user search engine experience this website subscribes to and uses readily available webmaster tools as provided by each Google and Bing;
2. as per standard throughout the internet these tools may load apps (aka "cookies" and "trackers") onto your device(s) – please note that this website's owners do not have any influence over what these third-party webmaster tools do;
3. it is each of these third-party webmaster tool providers' responsibility to advise visitors to its platform of its terms and conditions and for explaining its privacy policy;
4. device owners can delete/remove all cookies and trackers either manually via settings in their device's browser or by using proprietary apps such as "CCleaner" to name but one of many.
